

# Member volunteers after Katrina

As soon as Hurricane Katrina hit, I knew I wanted to do something to help the animals. People were losing their homes and everything they owned, and having to leave behind their pets made a tragic situation even worse. I knew if it were me, I would want to know my pets were safe and taken care of. I started emailing all of the national organizations doing hurricane relief work with pets, and after a couple weeks of waiting anxiously, Best Friends Animal Society was the first to contact me. They had set up a temporary shelter in Tylertown, Miss., and were caring for about 500 animals (over 2,000 animals have gone through the shelter to date, many are being fostered by groups all over the country). Best Friends was sending teams into New Orleans, LA. each day to rescue animals left behind when owners evacuated, as well as picking up animals from Jefferson Parrish Animal Control – these were the pets whose owners had tried to evacuate with them, only to be forced to surrender them.

After packing up enough food and water for myself for a week and driving 16 hours from Michigan, I arrived at Best Friends in Tylertown. There were hundreds of dogs and cats, and a few more unusual pets, including an emu, a pot-bellied pig, ducks, a couple of snakes and a turtle. I'd been told by Best Friends to expect the place to look like a war zone, so I was pleasantly surprised by the housing conditions for the animals – conditions for the people were another story; we slept in cars and tents. The cats were in nice air conditioned rooms, and the dogs were outside in fenced dog runs, and considering the temperatures were in the mid 90s, they were as comfortable as possible. They had tarps for shade and some even had industrial sized fans. They also had the "Dogloo" houses that Best Friends purchased to keep them dry when Hurricane Rita came through.

Volunteers had come from all over the country and even Canada. On any given day there were about 50 volunteers, many who worked with animal rescue groups back home, but a lot were like me and just came on their own because they love animals and wanted to help. Volunteers formed rescue crews that went into New Orleans and took pets left in houses or wandering the streets, they provided veterinary care and grooming, did laundry and cooked for other volunteers, and fed and cared for the animals. Some volunteers came planning to stay a week, and ended being there for a month or two instead.

Most of my first day was spent working with the dogs at "Ellis Island," where the new arrivals were kept. I loaded up wagons full of food bowls and scooped poop. Once that was done, someone asked if I was computer literate, and when I said yes, I was dragged off to the office. Most of the rest of the week was spent updating the database of all the animals and uploading digital photos so the animals could be posted on Petfinder.com for people who were searching for their pets. At first I was disappointed to be doing computer work instead of working with dogs, but I knew I should be grateful to be inside out of the heat (and the poop!), and the work I was doing was important. I ended up with plenty of dog contact too. We had a bunch of dogs in the office that needed special care or were too small to stand the heat. There was a mini Chihuahua who liked to sit on my shoulder instead of walking on a leash – she'd look down and growl at any big dogs we passed. I also spent a day organizing the round-up of over a hundred dogs to be flown to a sanctuary in Arizona called Tara's Babies. It was set up and run by Buddhist nuns and monks who wanted to help the animal victims of Katrina.

I got to be a part of a lot of the reunions when people came to look for their animals, since I was working on the database and could help search by breed or other description. It was exciting to see the pets reunited with their owners, and every time it happened, you couldn't find a dry eye in the place. I was also working at night when the rescue crews came in late at night. Each night the vets and vet techs set up a MASH unit outside to care for the animals that were in critical condition, there were more and more of these each night, it was amazing the animals were still hanging on over a month after the hurricane. They also brought in some of the animals for baths right away. The ones who were found outside were covered in sludge and many had chemical burns. Afterwards the rescue crews would come in and tell their stories. Sometimes I heard things that I wished I hadn't, like the night they brought in a dog who had been trapped and had chewed her own leg off, or a dog they rescued who had been not only left inside the house, but was chained to a refrigerator. He will be okay, but another dog in the house had already died. But there were happy stories too, like Himie the Rottweiler who was found with a bottle around his neck. Inside the bottle were his eye medicine and a note from his owner, who had stayed with his dogs as long as he could before being forced to evacuate. Best Friends posted the story on their website, someone tracked down Himie's owner at a Red Cross shelter, and volunteers are working to get them reunited.



Best Friends expects to keep the Tylertown sanctuary operational at least through the end of the year. They are currently dealing with the second wave of Katrina animals, the ones who made it out but whose owners are struggling to rebuild their own lives and are unable to care for pets. All of the animals are being held for 90 days, starting from their rescue or surrender; whether a forced surrender during evacuation, or surrenders now from people unable to care for them. Many pets won't be found or claimed, and many owners won't be able to take their pets back.

If you are interested in adopting a Katrina animal, there will be thousands who will need homes in the next couple of months. Rescued animals have been placed in foster care all over the country, and I'd be happy to help find a group in your area that has Katrina animals. This disaster has increased the total number of homeless animals, and adopting any shelter animal is a great way to help. Monetary donations are still needed as well, and can often be made through your local shelter, or through Best Friends, ASPCA, Humane Society of the United States or Noah's Wish. You can get updates on Best Friends' hurricane relief work on their website at [www.bestfriends.org](http://www.bestfriends.org).

**Even if you can't adopt an animal or make a donation, there are lots of ways that you can make a difference!**

- **Tell Congress not to abandon pets in disasters.** Sign the petition to support The Pets Evacuation and Transportation Standards Act (PETS Act, H.R. 3858), currently in Congress, that will protect pets in federal evacuation plans, and urge officials to save currently stranded pets. Go to [www.thepetitionsite.com/takeaction/](http://www.thepetitionsite.com/takeaction/) and choose "Don't Abandon Pets in Disasters" from the Animal Welfare list.
- **Want to help reunite pets and owners?** If you're comfortable with the Internet and willing to make long distance phone calls, you can work from home to locate owners of pets rescued from Katrina. Visit the Yahoo Groups website at <http://groups.yahoo.com/> and search for group "stealthvolunteers."
- **Have pets of your own?** Get a free rescue alert sticker for your window and learn how to prepare for an emergency on the ASPCA website at [http://www.asPCA.org/site/PageServer?pagename=pets\\_emergency](http://www.asPCA.org/site/PageServer?pagename=pets_emergency)
- **Contact Louisiana Governor Kathleen Blanco and ask her to reinstate permission for out of state veterinarians to come in and volunteer.** There are still thousands of animals being cared for in shelters in Louisiana and veterinarians all over the country who are willing to volunteer to provide veterinary care but are no longer permitted to by Louisiana.
